Investigative Report

Title / Subject: INVESTIGATION

On Monday, October 24, 2022 I received a radio broadcast to respond to 198 Crocker Rd (Barnes and Noble) in connection with a child custody interference. The following are the facts related to this incident;

Upon our arrival we spoke with Crocker Park Security Officer Jared Cooper who stated he received a phone call from [REDACTED] who advised him his 16 years old daughter [REDACTED] has not been home for the past two days. [REDACTED] also advised him that he believes [REDACTED] is with a 21 years old male from UK and is afraid the male is attempting to take his daughter with him. CPS was aware [REDACTED] had lost the phone and was looking for it. CPS was contacted by the male and [REDACTED] advising CPS they were looking for her lost phone. CPS then informed them they had the phone and could meet with them.

At this time CPS requested for our assistance. While speaking with CPS Cooper, he showed us a photo of [REDACTED] which [REDACTED] sent him in attempt to locate her. In company of Officer Hitchens #83 and Officer Santiago #86 we proceeded to the Barnes and Nobles and observed [REDACTED] utilizing a Barnes and Noble phone talking to [REDACTED] [REDACTED] was crying and emotional while on the phone) and a male later identified as Alexander K. Dunn beside her. We then approached them and separated them.

Upon beginning our interviews, we identified [REDACTED] and Alexander. Dispatch was provided with the information to ensure [REDACTED] was not listed as a missing person. Officer Santiago further requested a check on Alexander for anything derogatory.

Officer Santiago spoke with Alexander while Officer Hitchens I spoke with [REDACTED] Alexander stated he arrived from UK on Thursday, October 20, 2022 and is staying at Double Tree located at 1100 Crocker Rd, Westlake, OH 44145 room #438. Alexander stated he is staying until October 29th, 2022. Alexander reported he comes to the U.S. to meet with friends from Ohio, Georgia and Florida who he met through online gaming stating this was not his first trip. Alexander advised us he met [REDACTED] online through mutual online friends.

On Friday, October 21, 2022 he met with [REDACTED] later in the evening. He also met with her again at the hotel on Sunday, October 23, 2022 in the morning to go to Cedar Point. Alexander reported [REDACTED] took an Uber to the hotel and they also used an Uber as mean of transportation to get to Cedar Point. Once they left Cedar Point on Sunday, they came back and [REDACTED] stayed with him in his room. Alexander stated [REDACTED] did not want to go back home since she has been having trouble with her mother. Alexander reported [REDACTED] and him came to Crocker Park so she could get her cell phone. Upon asking Alexander how was he able to meet with [REDACTED] on Sunday if she did not have her phone, Alexander stated because that was the plan.

It was later learned from [REDACTED] that the Uber rides were payed by Alexander. This contracted Alexander's statements that he ran into [REDACTED] randomly.

While I spoke with [REDACTED] [REDACTED] stated she met with Alexander on Saturday, October 22, 2022 in the evening at Crocker Park and she spent the night at his hotel room (Double Tree Room # 438). On Sunday, October 23, 2022 they got an Uber and went to Cedar Point for the day.

While speaking with [REDACTED] I was interrupted by a male later identified as Brian Petrik who was concerned about my interaction with [REDACTED] At the time of the initial contact of [REDACTED] she was very upset and crying. During our conversation I was attempting to calm her down. Due to Petrik interrupting, I advised Petrik that [REDACTED] was ok and I was conducting business with her. Brian then left reluctantly, and I

noticed that Petrik's interruption made [REDACTED] more upset.

I was able to calm [REDACTED] down a little bit. Speaking with [REDACTED] I learned she brought two changes of clothes with her when she met with Alexander. [REDACTED] reported she did not bring any money with her and as far as a hygiene product she obtained it from the hotel where Alexander is staying. While speaking with [REDACTED] I noticed a body odor coming from her person as if she had not been showering. [REDACTED] skin also appeared shiny and oily along with her hair. [REDACTED] stated that Alexander provided her with other basic needs such as food and hydration.

As I continued to speak with [REDACTED] she stated she takes anti-depressant and sleep medication. At this point of the interview, we were reproached by Petrik who again wanted to intervene. At this time, I observed that Petrik was slurring his words and not making sense. Petrik then persisted with his action and was ordered to leave multiple times. [REDACTED] became upset to the point of our initial encounter. I then ordered Petrik to leave which he eventually did.

After Petrik's second encounter I noted that [REDACTED]'s demeanor with me changed and requested Officer Hitchens to speak with her. While officer Hitchens spoke with [REDACTED] I proceeded to the inside of Barnes and Noble and conferred with Officer Santiago and Alexander. While attempting to speak with Alexander, he requested for Officer Santiago to inform me of his statements. Alexander eventually provided me with a statement and added that he did meet with [REDACTED] on Saturday, October 22, 2022. Alexander reported he ran into [REDACTED] while he was at Crocker Park with their mutual friend unexpectedly. Upon asking Alexander the name of their mutual friend, Alexander refused to provide us with it.

At this point of time Officer Santiago and I convened and compared the statements Alexander provided to Officer Santiago initially to the statement provided with me present. Due to the different statements made from [REDACTED] and Alexander we approach Alexander and advised him he was being detained for further investigation. Officer Santiago then asked Alexander if he was aware of the Miranda Rights, which he stated he was. Officer Santiago then advised Alexander of the Miranda Rights which he stated he understood.

During the interview Alexander reported he communicates with his friends in the U.S. through discord app. Having knowledge that this is a app used by sexual predator we became concerned of [REDACTED]'s welfare. Alexander informed me he was an online gamer who specialized in Lego games. He stated he earns money from proceeds of an online gaming blog that he and his friends run. It is through this blog that he stated that he had made friends abroad.

At this point Richard arrived to our location and Richard was advised of our findings up to this point. Due to the situation we requested for a supervisor to arrive on scene. After conferring with Sgt. Shelby who arrived on scene, we requested Dispatch to contact D.H.S. in attempt to properly identify Alexander to ensure there was no open investigation.

Around this time, I went outside to speak with Richard and inform him of the information we had obtained up to this point. During the investigation I learned that [REDACTED] is in the 11th grade and is enrolled in [REDACTED]. I also learned that [REDACTED] suffers from mental health issues and Richard stated that she has not taken her medication for the last two days. I also spoke with [REDACTED] who denied any sexual behavior between her and Alexander during the visit.

At some point in the interview Alexander was asked if he had any nude photos of [REDACTED] on the phone. I also asked him for consent to search his phone which he denied. I then asked him for consent to take his finger prints and DNA which he denied.

We later learned from Officer Hitchens that [REDACTED] had sent nude photos to Alexander, possibly through the Snapchat app, several months prior. It should be noted that Alexander informed Officer Santiago that he had traveled to Westlake previously, which was later confirmed by [REDACTED] (sometime in August 2022). These facts were relayed to Prosecutor Corrigan. Prosecutor Corrigan agreed that the phone should be seized with the intent of an application for a Search Warrant for the contents of the phone. The phone was Seized from Alexander and he was explained of the process.

Alexander was informed that the seizure of the phone was due to [REDACTED]'s admission that she sent him nude photos in the recent past. Alexander confirmed this happened but stated the photos he received were unwanted and not by his request. Alexander was left with contact information for WPD. Alexander requested if he could access his phone to retrieve information due to the fact that he had a "Mac" at the hotel room and required dual factor authentication to access. Due to potential evidence preservation issues this request was denied. Alexander would not provide us with the passcode of his phone. Alexander seemed concerned and later asked me if there was an issue if he had nude photos of adults on his phone. Alexander then walked away from the scene.

Officer Hitches also learned that [REDACTED] was the account holder and payee of [REDACTED]'s phone. [REDACTED] provided a consent to search form to [REDACTED] who competed same. The phone was turned over to Officer Hitchens.

Both phones were placed into airplane mode and placed into the BEAST by Officer Hitchens.

This report was prepared by both Officer Krebs and Officer Santiago.
